The Association holds one meeting a year to conduct it's business which includes election of officers, by-law changes and affirm the business of the Board of Directors. The Board of Directors meet four times a year to monitor the business of the Association and to pay the bills. The Educational Committee reports to the Board of Directors for approval of seminar and annual educational conference and meeting locations and dates.

PROFESSIONAL DEVELOPMENT

NEAFM currently sponsors one day educational seminars twice a year in Auburn, Massachusetts. These seminars are held in conjunction with PARADE REGION 1 in to bring timely educational topics to fire prevention professionals throughout the New England States. These one day seminars are open to members as well as non members to help promote better enforcement and understanding through education. The Association usually holds their annual two day conference and annual meeting in the month of September.

OBJECTIVES and PURPOSE

MEETINGS

NEAFM holds one formal meeting each year during the annual two day conference. The Board of Directors usually convenes four times a year.

MEMBERSHIP

Membership in the New England Association of Fire Marshals shall be open to:

Federal, State, and Local Fire Marshals and their deputies, the staffs of Fire Prevention Bureaus, Fire Department personnel of all ranks with a primary interest in fire prevention, and officials of state, County, and Municipalities charged with the duty of investigating the cause and origin of fires; and Individuals who support fully the efforts of the fire service and this Association to bring about a reduction in the loss of human lives and the destruction of property by fire and the suppression of arson.

Applications for membership shall be made by written application on forms provided by the Association and submitted to the Secretary/Treasurer. The Board of Directors shall, at its sole discretion, determine any applicant's qualification for membership.

Honorary Life Membership may be conferred upon any member in good standing of the Association retiring from office after ten or more years' service as a Federal, State, County, or Municipal Fire Marshal, or as full-time members of the staffs of these officials, or who has rendered outstanding service to the Association.
